He was a founding board member of the non-profit Chartered Financial Analyst (CFA) Institute of Japan, and a board member and treasurer of the American School in Japan. In the United States, Mr. Plum was a board member and treasurer of Doctors Without Borders in New York City.

Mr. Plum received a bachelor of science from Massachusetts Institute of Technology (MIT). Following graduation, he remained actively involved with his alma mater, serving as a board member of MIT’s Alumni Fund, Alumni Association, Alumni Association of Northern New Jersey, and MIT Alumni Association of Japan.
