Open visitation has resumed at Longview!

10 a.m. to 8 p.m. seven days a week

Pre-scheduled visitation is no longer required!

- The number of visitors is not limited; however, we request that families be respectful and sensitive to social-distancing requirements in public areas. Families may be asked to move their public visiting location to a designated area in order to maintain social-distancing requirements.
- Anyone 2 years of age and older can visit, as long as they can wear a mask.
- Pets may also visit in the privacy of a resident's room or in a designated outdoor location.
- All visitors must enter through reception, screen, have their temperature taken, and wear a visitor's pass. Further instructions will be provided after the screening process.
- To ensure the safety of our residents, outdoor public areas will not be open for direct entry from parking lots. You must screen first.
- Visits are for social purposes only. Families are encouraged to call Nursing to address specific resident concerns separate from their time of social visitation.
- Well-fit surgical masks must be worn by visitors and residents at all times, inside and outside.
- Visitors may bring any items they have brought with them directly to the resident's room.
- For the safety of others, no food or beverages can be shared in any public areas. Food and beverages can be shared only within a private resident room.
- Please do not attend organized group activities. Space is limited to facilitate social distancing requirements.
- No entry is permitted into resident dining rooms or the Village Café while meals are served.
- Beauty salon visits still need to be scheduled. Please do not bring your loved one to the beauty salon for service without an appointment.
- Out-of-state visitation guidelines:
 - ◊ Out-of-state visitors from New York, Pennsylvania, Connecticut, or Delaware are cleared for visitation.
 - ◊ Visitors from any other state/country who are fully vaccinated are cleared for visitation.
 - ◊ Visitors from any other state/country who are unvaccinated are not cleared for visitation unless they have already quarantined within New Jersey for 10 days before coming to Christian Health.
- Visits in a semi-private room guidelines:
 - ◊ To ensure social distancing, visitors can be in a resident's semi-private room with a maximum of two visitors for any one resident.
 - ◊ Visitation can only occur within a semi-private room if the resident's roommate has provided consent to allow visitors in the room and only if both residents have been vaccinated. Please inquire at the reception desk.
 - ◊ If visiting within a resident room, visitors must stay on their loved one's side of the room. Resident room doors must remain open while visitors are present.
- When taking photos/videos of your loved one, please do not take photos/videos of other residents or team members without their explicit consent. Be mindful of anyone who may appear in the background or who may walk by when you are taking photos/videos. Please also refrain from taking photos/videos of areas where resident names may be displayed.
